
2024 PRIORITY LEGISLATION

Affordable Housing

AB 2728 - GABRIEL

Follow-up Bill Tracking SB 4 Housing

This bill would add new stakeholder feedback and accountability measures for SB 4 (Affordable Housing on Faith and Higher Education Lands Act of 2023). It will encourage cities & counties to plan for and incentivize affordable housing production on faith organizations' owned land. SB 4 utilization data will have to be reported. Additionally, will require the Dept. of Housing & Community Development to compile and develop important info for prospective builders and eligible landowners.

AB 1851 - HOLDEN

Clean Drinking Water in Schools, Lead Testing

A revised version of AB 249 (Holden) from 2023, this initiation of a pilot program would require the hiring of a nonprofit technical assistance organization by the Superintendent of Public Instruction to test all potable water system outlets in no fewer than 6 and no more than 10 local educational agencies & to report and remediate those systems found to have lead levels in excess of 5 ppb. Would additionally require the organization to write a report and follow up on the remediation efforts being done by school districts by Jan. 1, 2028. Final program results would be completed by July 1, 2028.

SB 1497 - MENJIVAR

Polluters Pay Climate Cost Recovery Act

This bill would establish the Polluters Pay Climate Cost Recovery Program to be administered by California EPA; this would require fossil fuel polluters to pay their fair share of the damage caused by the sale of their products during the covered period (2000-2020). It would also require CA EPA to conduct a climate cost study to quantify the total damage amount, which would be defined as all past & future climate harms & damages to the state through 2045.

Economic Justice/Ending Poverty

AB 2191 - SANTIAGO

Free Tax Prep & Community Engagement

This bill would establish the CalEITC Outreach, Education, & Free Tax Assistance Grant Program. Upon appropriation, the bill would require the Franchise Tax Board to allocate grants to qualified nonprofit community-based orgs or local government agencies to increase the number of eligible households claiming the state and federal Earned Income Tax Credit (EITC), Child Tax Credit (CTC), Young Child Tax Credit (YCTC), and the Foster Youth Tax Credit (FYTC), and to increase awareness of ITIN tax status eligibility.
